**VENDOR HOLD HARMLESS AGREEMENT**

In consideration of all the work done by the Vendor, he/she hereby indemnifies and hold harmless the Laclede's Landing Merchant's Assoc. (hereinafter referred to as "LLMA"), the City of St. Louis, its Board members, their officers, agents, and their employees and volunteers from any personal injury, costs and expenses, occurring to anyone in, or about the area of said concession. That the Vendor is acting as an independent contractor not under the continuing supervision and control of LLMA or the City of St. Louis. I also agree that LLMA and the City of St. Louis shall not, under any circumstances, be liable under or by any reason of the Agreement, directly or indirectly, for any accident, injury, breakage or damage to property or persons whatsoever growing out of any activities relating to the Big Muddy Blues Festival activities. Vendor agrees to abide by all Federal, State, County and Municipal laws, ordinances, regulations, guidelines and rules. Vendor agrees to be responsible for all employees, agents and contractors of concessionaire. Any Vendor or employee, agent or contractor of Vendor who violates any such law, ordinance, regulation, guideline or rules in connection with the operation of the concession, shall forfeit the concession and be disqualified from participating in Big Muddy Blues Festivals in the future. In this event, Vendor shall cease all business activities and vacate the premises immediately forfeiting all fees.

**Liability and Loss**

LLMA and the City of St. Louis assume no liability for loss or damage to any property of the Vendors due to fire, tornado, weather conditions, vandalism, theft or other cause. LLMA and the City of St. Louis shall not be responsible for any breach of law by Vendors or their employees or contractors. Vendors agree not to bring any suit or damages against LLMA or the City of St. Louis for any personal injuries or property damages which may occur to Vendors or their employees or contractors. Vendor is acting as an independent contractor not under the supervision and control of LLMA or the City of St. Louis.

**Indemnity**

Vendor acknowledges that they have complete control over the sourcing, preparation, storage and service of their products. Vendors agree to indemnify, hold harmless and defend LLMA and the City of St. Louis, and its officers, agents, directors, board members, employees and volunteers, from any claims, liabilities, losses, personal injury, costs and expenses, damages, lawsuits, actions and attorney fees arising out of the Vendors' participation in the 2016 Big Muddy Blues Festival, the provisions or sale of the Vendors' products at the 2016 Big Muddy Blues Festival and any actions or omissions of the Vendors' agents and/or employees – whether intentional, reckless or negligent – in connection with the Vendors' participation in the 2016 Big Muddy Blues Festival and the provision or sale of its products at the 2016 Big Muddy Blues Festival, including but not limited to any claims for bodily injury (including death), medical expenses or pain and suffering.

**Termination**

Vendor agrees to be responsible for all employees, agents and contractors of Vendor. Any Vendor or employee, agent or contractor of Vendor who violates any such law, ordinance, regulations, guideline or rule in connection with the operation of the concession, shall forfeit the concession and be disqualified from participating in the Big Muddy Blues Festival in the future. In this event, concessionaire shall cease all business activities and vacate the premises immediately forfeiting all fees.
